

## DECLARATION OF CONSENT: PHOTOGRAPHS AND IMAGE RECORDINGS

## **APPENDIX 1 - INFORMATION CLAUSE**

**– for natural persons; applied to personal data obtained by Domeguru Sp. z o.o. from anyone other than the data subject (Article 14 of the GDPR)**

### **3. Purposes and Grounds for Processing**

Each consent may be withdrawn at any time, without affecting the lawfulness of processing carried out prior to the withdrawal.
